

DIRECTIONS FOR OBTAINING EARLY CHILDHOOD GENERALIST ENDORSEMENT AT THE OHIO STATE UNIVERSITY

The Ohio State University offers an endorsement program to add 4th and 5th grades to an Early Childhood teaching license for teachers holding a standard Ohio license in Pk-3. This endorsement cannot be added to any other teaching license.

If your Ohio certificate/license has expired, contact the Ohio Department of Education (ODE) at 614-466-3593 for information on renewing your original certificate. If your credential expired less than five years ago, you will need to take nine quarter hours of course work in your discipline. If your credential expired more than five years ago, you will need to take 18 quarter hours of course work in your discipline. If you have questions about which courses fall within “your discipline,” ask to speak to a consultant at the ODE. Depending on your original teaching area, you may or may not be able to use the required 4th and 5th grade endorsement courses to renew your certificate/license.

If you received a teaching credential from another state and need information about obtaining equivalent licensure in Ohio, contact ODE at 614-466-3593 or visit the Web at <http://www.ode.state.oh.us/> for an out-of-state application and information packet. **PLEASE NOTE:** Candidates who were prepared as elementary teachers in other states and who received a broader elementary license in the originating state but were required to obtain a P-3 license in Ohio, now will be able to apply for the new early childhood generalist endorsement based on the preparation they initially received in their originating state. While these educators will *not* need to complete additional coursework requirements through an Ohio college or university, they are required to meet the Praxis II testing requirement. Step 1

Complete the “enrollment” section of this document. Contact the Ohio State Newark advising office and make an appointment for a face-to-face, telephone conversation, or e-mail communication with either Marilyn Barber or Karen Prost to discuss enrollment and registration. The Ohio State Newark Advising Office contact information is below. You will need to make available to the advising office copies of your transcripts and a copy of your current teaching license as well as the completed Enrollment form.

Step 2

Successfully complete all of the courses listed on the “Early Childhood Generalist Endorsement Sheet” and earn a minimum GPA of at least 2.7. This coursework can be taken for undergraduate

or graduate credit and each course should be taken for 3 credit hours. In addition, all coursework must be completed at Ohio State to be recommended for the Early Childhood 4/5 Generalist Endorsement to be approved by this institution. The faculty must approve any exceptions. A student wishing to substitute a course or a course from another institution must submit a petition, a course syllabus or official course description, and a copy of a transcript or advising report showing the final grade. Petitions are available in the Ohio State Newark Advising Office and should be returned to that office.

Step 3

Pass the Praxis II National Teacher's Exam, "Elementary Education: Content Knowledge." Check the ODE Web site at <http://www.ode.state.oh.us> to confirm that you are registering for the appropriate test. Search for "Praxis II Tests," then click on "PDF outlining ODE's Praxis II testing information for Ohio teachers." Registration information is available on the Praxis Web site at <http://www.ets.org/praxis>. Have your scores sent to The Ohio State University (reporting code **R1592**). Allow approximately 6-8 weeks for the results to be posted to your transcript.

Step 4

Notify Ohio State Newark Advising that you have completed the requirements by sending in the "Early Childhood Generalist Endorsement Clearance Request Form" which an advisor can help you get processed.

Step 5

Apply for licensure. Applications are available on the Ohio Department of Education Web site at <http://www.ode.state.oh.us/>. Complete this form and submit it with a check or money order for \$20 (made payable to **Treasurer – State of Ohio.**) to:

As soon as final grades for all required courses have been posted, and the University Registrar has received your PRAXIS scores, your application for licensure will be approved and forwarded to ODE with your check or money order.
